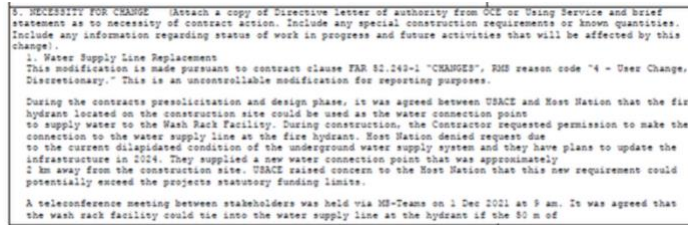

2 New Features / Changes / Issues Fixed

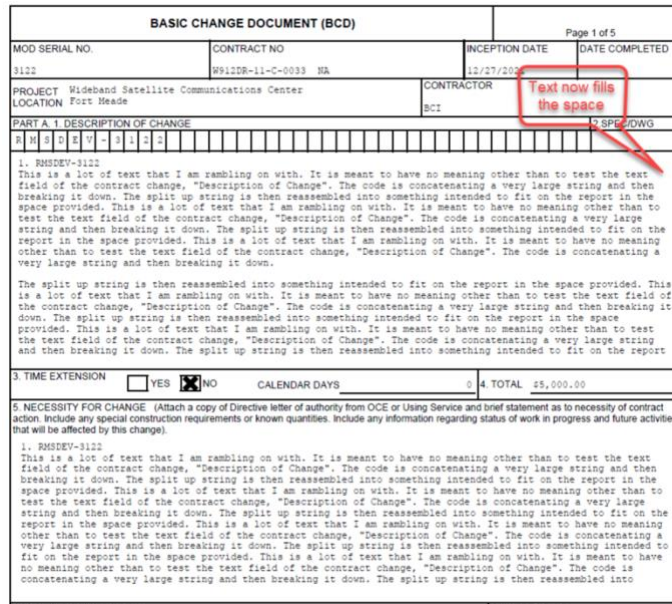
1. Fixed Issue with BCD Report Wrapping Text Incorrectly

The Basic Change Document report was not wrapping text correctly. The BCD Report is in the Finances → Contract Changes → Open a Contract Change and BCD will be on the upper right hand corner of the module.

4. Transmittal Remarks ENG 4025-R Report Fixed

The Transmittal 4025 Remarks report now correctly displays each transmittal on its own page with the list of submittal items. Also, each remarks section can have up to around 32,000 characters inputted into RMS and exported out to the report – (anything past this is saved in RMS but displays a [...] on the printed report past 32,000 characters) – this no longer crashes the report generator when dealing with these many remarks.

5. Contractor Status Sheet Summary Fix

Corrected a problem with the Contract Status Sheet (Summary Version) where the project manager would not dynamically change based on the contract type – the titles are now listed as: Project Manager, Resident Engineer, and Project Engineer. Before it was listing the Office Manager instead of the Resident Engineer.

6. Contractor Payroll Fix

When attempting to export the Progress Payment to PDF or Excel – headers were incorrect. This has been fixed.

7. Fix for Submittal Item Number Sorting

In the Submittal Assignments module – (Open a Contract → Submittals → Submittal Assignments) – the Update → Assign Activity --- the item numbers were all zero for the section numbers. This has been fixed:

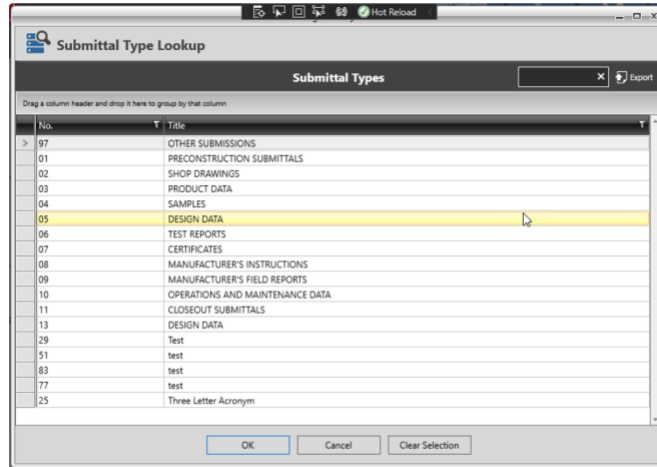

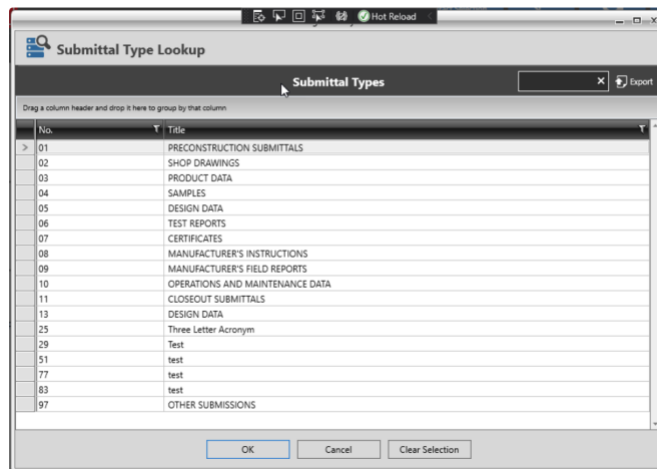
